INSTRUCTIONS FOR TRAFFIC AND CRIMINAL FORMS

1. Request for Continuance Form:

- a. Case types form may be used in
 - i. Criminal Cases
 - ii. Traffic Cases
- b. By whom may this form be used
 - i. Pro se defendants
 - ii. Defendants' attorneys
- c. Complete **Part 1** of this form by entering defendant's full name, case number, upcoming hearing type, upcoming hearing date, number of times this request has been made, the reason for the request, the type of hearing requested if continuance is approved, movant's name and contact information, date, and sign.
- d. Submit this request to the Bryan County Solicitor General via email at sherri.olsen@bryancountyga.gov AND jennifer.kyper@bryancountyga.gov for review.
- e. **Part 2** shall be completed by the Solicitor and forwarded to the Bryan County State Court Judge for approval or denial, as indicated in **Part 3**.
- f. **Part 4** shall be completed by the Clerk. The Clerk will notify the movant of the Judge's decision and reschedule the hearing if necessary.

PRIOR TO HEARING DATE ****

2. Waiver of Arraignment and Plea of Not Guilty Form:

- a. Case types form may be used in
 - i. Criminal Cases
 - ii. Traffic Cases
- b. By whom may this form be used
 - i. ONLY Defendants' attorneys
 - ii. Pro se defendants may NOT use this form
- c. Complete this form by entering defendant's full name, case number, indicate whether defendant is electing a bench trial or jury trial, indicate whether defendant opts in or opts out of the Statutory Criminal Discovery provisions, defendant's attorney must provide their contact information and sign and date in both sections indicated.
- d. Defendant's attorney must submit this form at least two days prior to the scheduled arraignment to the Bryan County Clerk of Court.

3. Request to Re-docket Form:

- a. Case types form may be used in
 - i. Criminal Cases (by defendant's attorney only)

- ii. Traffic Cases
- b. By whom may this form be used
 - i. Pro se defendants in traffic cases only and may be used ONE time
 - ii. Defendants' attorneys
- c. Complete **Part 1** of this form by entering defendant's full name, case number, original hearing type, original hearing date, enter defendant's name, date, provide all requested contact information, and sign.
- d. Submit this request **in-person or by mailing** to the Bryan County Clerk of Court with a payment of the \$75.00 redocketing fee (no other fees shall apply). The clerks can accept fee payments in the form of cash, money order, or cashier's check. They are unable to accept card payments or personal checks.
- e. **Part 2** shall be completed by the Clerk. The Clerk will notify the movant of the rescheduled the hearing date if this request is granted by the Court. The Clerk will not withdraw any failure to appear nor notify the Sheriff to recall any bench warrant until the following occur: (1) Movant appears before the Court, and/or (2) the Court orders the withdrawal or recall.

4. Plea in Absentia Template:

- a. Case types form may be used in
 - i. Criminal Cases
- b. By whom may this form be used
 - i. ONLY Defendants' attorneys
 - ii. Pro se defendants may NOT use this form
- c. Use the Plea in Absentia template found on the website here:

- d. Complete the form by entering defendant's full name and case number in the case caption. Input defendant's full name in the body of the form and in signature line.
- e. Input each of defendant's charges in section 2.
- f. Input each sentence including fines, previously negotiated with the Bryan County Solicitor General, in section 2. For complete instructions, visit the website here:

- g. Input defendant's current address and phone number in section 5.
- h. Defendant must sign where indicated before a notary public.
- i. Submit this form and proposed order on plea in absentia for review to the Bryan County Solicitor General via email at jennifer.kyper@bryancountyga.gov AND sherri.olsen@bryancountyga.gov.
- j. The Solicitor General will present the form and proposed order to the Court for approval or denial.
